Down spout on the NE corner of the pavilion needs to be drained to the creek. We are able to do this ourselves. Keith called Holmes Rental to rent a ditcher at \$229.00 per day and \$2.10 per mile for delivery and pick up. We also will need 100 feet of 4" pipe.
