Wayne has a quote for the end of the pavilion and is waiting on another one.

Keith trimmed the tree at the park.

Wayne has a layout for the new restroom down at the park.

### **STREET/**EQUIPMENT:

#### **Bob Miller-**

According to the state, our work machinery or trucks' emergency lighting is not up to code. Keith said we are looking for about \$400-\$500 for lighting to get up to code on these.

Motion to spend up to \$400 on lighting by Bob Miller,  $2^{nd}$  by Wayne Troyer: roll call vote by six (6) ayes.

Keith is also looking into buying a motorized hole digger for cremation burials, instead of taking the backhoe up there and making a big mess. The cemetery is all clay up there and it's all rock hard. A battery-powered one is about \$350 and a gas one is about \$500. Keith is going to get quotes on these for the next council meeting.

Bob checked out prices on cement blocks from Pleasant Valley for \$85, Holmes Ready Mix has 2x2x6 for \$120 and Quality Block in New Philadelphia was \$55. Keith said that he would like to have about 6 of the blocks.

Motion to spend \$330 for 6 blocks from Quality Block in New Philadelphia by Tom Richter, 2<sup>nd</sup> by Bob Miller: roll call vote by six (6) ayes.

There is about 70 feet on Orchard Drive that the pavement got lowered and the catch basin needs stone filled in and replaced.

Motion to approve \$700 to buy stone and catch basin to replace Orchard drive by Tom Richter, 2<sup>nd</sup> by Wayne Troyer: roll call vote by six (6) ayes.

The plow truck is up and ready for the winter season.

18 street signs need to be replaced.

Motion to \$270 for 18 street signs from the County by Garrett Kurtz, 2<sup>nd</sup> by Bob Miller: roll call vote by six (6) ayes.

We are losing shingles off the cemetery shed and he dug out at the park. Garrett has a quote from Miller Roofing and a second quote for the next meeting.

The side of the main shop is coming off and looking rough.

Christmas lights have been put up and the park has been winterized by Wayne. Big Thank you to Wayne for doing that.

The cemetery tree fell. Keith passed out pictures of what the tree looked like.

Keith had a couple of quotes for the trees from Cline Bros and Yoder Tree Service and that is tabled for now.

### FINANCE:

#### Tom Richter-

Discussed the billing for EMS. Start-up costs will be roughly about \$10,354 for certifications, software, etc. Tom is suggesting to the council to have Dena do this and she will have an hourly pay of \$25/ hour, a rough estimate of 3 or 4 hours a week for this. After 90 days, Dena would go up to \$26/hr and then a yearly 2% every June like other Village employees.

Motion to have Dena do the EMS billing by Tom Richter,  $2^{nd}$  by Wayne Troyer: roll call vote by six (6) ayes.

Park rates change from \$75 to \$100 with no lights, \$125 to \$150 with lights, \$125-\$175 Pavillion rental: \$250-\$300 Pavillion & ball fields. Will do a contract and have them sign and do a deposit fee for cleaning. A \$50 deposit will carry over. Community Club meeting on Thursday evening at Village Hall at 5 pm the mayor will talk to them about this.

Tom talked about making a time-of-service bonus and starting that at \$1000 for the first year and then discussing further years at another meeting.
