Sunset, Prospect, Cherry, Hahn Dr. North, Lutheran Dr, Freese Dr, and Orchard Dr. East End are on that list. They will tell us what the cost is for that, and we can either add or take away from the list and will have until March 30, 2025, to fine-tune that list of streets.
